### TCA DESCRIPTION

**Themes and goals:** Social responsibility is reflected in the impacts of policies, decisions and activities on society and the environment, exercised through ethical and transparent behaviour. This TCA intends also to contribute to the discussion on the inclusion component of the new programme, to identify potential synergies between the AE and HE sectors that could lead to new cooperation schemes in favour of inclusion, to have the opportunity to think about the meaning of inclusion associated to the CRS as a tool for the improvement of social inclusion.
